To assist the court and the parties at oral argument, the court orders:

With regard to the Sewerage Districts contention that the trial court erred in changing the jurys answer to the statute of limitations question:

The Sewerage District shall, within 14 days of this order, submit, with a copy to opposing counsel:

1. A list identifying each exhibit that the jury saw or about which the jury heard (if that exhibit was received in evidence) that supports the jurys answer to Q 6 of the Special Verdict. The list shall be numbered sequentially and: (1) identify the document by date and author; (2) identify the document by exhibit number with Record and appendix references; (3) specify by Record reference the places where it was either shown to the jury or where the jury learned about it. If the document and parts of the transcript where it was published to the jury are not already part of an appendix, the document and pages of the transcript where it was published to the jury shall be reproduced and attached to the list.
2. A list citing to the jury trial testimony that supports the jurys answer to Q 6 of the Special Verdict. The list shall identify: (1) the witness; (2) his or her relationship to the transactions he or she describes; (3) a 1-3 sentence summary of his or her testimony that supports the jurys answer to Q 6 of the Special Verdict; (4) the Record and appendix references where that testimony appears (if that testimony is not already part of an appendix, the material parts of that testimony shall be reproduced and attached to the

list).

3. Counsel for the district may include a 1-2 page summary of the significance of the above-described lists.

Counsel for Bostco may, if it desires, submit its own lists of exhibits and testimony, with the same requirements as described above, and may include a 1-2 page summary and comment on the exhibits and testimony excerpts identified by the Sewerage District's list.
