ORD that the motion of Unnamed Movants' 2-7 for clarification is granted in part, as set forth in this order. The remaining requests for relief in the motion are denied.

FRO that the John Doe judge has full authority, as set forth above, to take all actions to effectuate the mandate of this court, as set forth in this court's July 16, 2015 and December 2, 2015 decisions, including the closure and wind up of those John Doe proceedings, and full authority to address all collateral matters not addressed by this court in its decisions and orders so long as the John Doe judge's actions do not undo or are not inconsistent with this court's July 16, 2015 and December 2, 2015 decisions.

FRO that electronic copies of the records in Milwaukee Cty. Case No. 2012JD23 and Dane Cty. Case No. 2013JD9 are remitted to the clerks of those respective circuit courts. The clerk of this court shall provide the original paper records and an electronic copy of those records to the John Doe judge for his use and disposition in his discretion pursuant to applicable law. The John Doe judge shall have full authority to make decisions regarding access to, and use of, said records.

FRO that the clerk of this court shall transfer to the custody and care of the John Doe judge the John Doe evidence submitted to the clerk pursuant to this court's December 2, 2015 opinion and order. The John Doe judge shall have full authority to make decisions regarding access to, and the disposition of, that evidence. The John Doe judge shall also have full authority to take actions regarding access to, and the disposition of, any John Doe evidence that should have been gathered and submitted pursuant to this court's December 2, 2015 opinion and order, but was not.

FRO that the mtn to stay all further proceedings in the underlying JD invest is denied at this time. Proceedings may cont in any or all of these matters unless and until this crt ords otherwise. FRO that the req in the writ pet for orders prohibiting any reserve judge to serve as the JD judge and prohibiting either a JD judge or a spec pros from using a p.o. box for the delivery of documents related to the investigations are denied, and no resp are req on those issues. FRO that the JD judge and spec pros must respond to the four remaining issues in the writ pet and the mtns to seal and unseal various docs. At a min, they should address: (1) both the factual basis and legal authority for the assignment of a single reserve judge to handle JD investigations in multiple counties or admin districts; (2) the basis for the appt of a spec pros and the scope of his authority to act in multiple counties or jud admin dist; (3) the scope of the secrecy orders, and (4) whether any of the petitioners subm to this crt should remain under seal. They should also provide this court with copies of any materials in their possession relevant to these issues. FRO that the chief judges of the four jud admin districts at issue may, but need not, respond to the writ pet. The chief judges shall be exempt from this courts order sealing the petitioners writ materials so that they may eval whether to participate. If the chief judges need access to any other materials that may be subject to a secrecy ord in ord to prepare any resp that any of them elects to submit, and they do not already have access to the JD invest, they should seek an exemp from the JD judge. FRO that resp shall confer with one another to determine whether they intend to file a joint resp or sep resps addressing the issues most relevant to each of them; and who will be representing them. The resps shall then, within 5 business days of this order, notify opposing counsel as to how they can each be served. The petitioners shall have an addl 3 business days to serve the writ pet and all accompanying materials upon the resp. Resp shall then have 20 days to file their resp. required by this crt. FRO that if any of the resp believe that some or all of their subm should remain confid, they should file subm under seal & present crt w/ arg as to why they should remain under seal and for how long. Fro
