RULE 809.50, except as follows: The appellant need not file a docketing statement but shall immediately make all necessary arrangements for the preparation of necessary transcripts and identify the relevant portions of the record to enable the clerk of the circuit court to transmit the record to the clerk of this court within forty-five days of the date of this order. FRO that the time for the appellants brief is extended to forty (40) days from the date an opinion is released by our supreme court in the OBrien consolidated appeals.
