STAT. 59.40 to the clerk of this court within three (3) days of the receipt of this order. Entry of this order has the effect of the filing of the notice of appeal, WIS. STAT. RULE 809.50, except as follows: The appellant need not file a docketing statement but shall immediately make all necessary arrangements for the preparation of necessary transcripts and identify relevant portions of the record to enable the clerk of the circuit court to transmit the record to the clerk of this court within forty-five (45) days of the date of this order.
