IT IS FURTHER ORDERED that the record shall be transmitted back to this court within five days of the disposition of the post-judgment motion or the filing of the transcript of the post-judgment motion hearing if ordered. The record shall include the proceedings on remand. See WIS. STAT. 808.075(7). IT IS FURTHER ORDERED that the time for filing the appellants brief is extended to fourteen days after the return of the record to this court and the appellants brief shall present all grounds for relief. WIS. STAT. RULE 809.107(6)(am).
