IT IS FURTHER ORDERED that counsel shall file a statement on transcript within five days of any hearing held pursuant to this remand order, specifying either that a

IT IS FURTHER ORDERED that the clerk of circuit court shall retransmit the records to this court within fifteen days of the later of the entry of the circuit court order resolving the postdisposition motion or the filing of any transcript of the postdisposition hearing, if such transcript is ordered. The record shall include documents filed pursuant to this remand; the transcript of any proceedings held pursuant to this remand order and as specified in the statement on transcript; and a written order reflecting the circuit court's findings and conclusions.
