IT IS FURTHER ORDERED that Kevin G. shall file his postdisposition motion in the circuit court within fifteen days of the date of this order. IT IS FURTHER ORDERED that the circuit court shall conduct any necessary proceedings and enter an order containing its findings and conclusion resolving the postdisposition motion within sixty days of the date of this order. IT IS FURTHER ORDERED that within three days of any hearing held pursuant to this remand order, counsel shall order a transcript so ordered shall be served and filed within twenty days of the date on which it is ordered. Counsel for the appellant shall provide the court reporter with a copy of this order. IT IS FURTHER ORDERED that counsel shall file a statement on transcript within five days of any hearing held pursuant to this remand order, specifying either that a		

transcript of the postdisposition hearing has been ordered or that such a transcript is not necessary for this appeal. IT IS FURTHER ORDERED that the clerk of circuit court shall retransmit the records to this court within fifteen days of the later of the entry of the circuit court order resolving the postdisposition motion or the filing of any transcript of the postdisposition hearing, if such transcript is ordered. The record shall include documents filed pursuant to this remand; the transcript of any proceedings held pursuant to this remand order and as specified in the statement on transcript; and a written order reflecting the circuit court's findings and conclusions. IT IS FURTHER ORDERED that Kevin G. shall file a brief presenting all grounds for relief no later than fifteen days after the records are retransmitted to this court. See Wis. Stat. Rule 809.107(6)(a)-(am) (2013-14).
