FRO that Ziehr's jail sentence is temporarily stayed pending the trial court's order reconsidering her motion for bond pending postconviction relief. FRO that if the trial court denies Ziehr's motion, its order shall specify the date on which Ziehr is to report to jail. If the trial court determines that Ziehr is a candidate for bond pending postconviction relief, it shall require the defendant to post a bond in accordance with Wis.
