K.C. shall provide a copy of her brief or any other response to the guardian ad litem, Attorney Lisa Bouterse, and the appellant's counsel, Attorney Christine Quinn.
IT IS FURTHER ORDERED that the guardian ad litem shall file a brief no later than December 4, 2015.
IT IS FURTHER ORDERED that under WIS. STAT. RULE 809.107(6)(c), the ten-day period for the appellant to file a reply brief commences upon service of the respondent's brief or the guardian ad litem's brief, whichever occurs later.
