<p>ORD that the record in appeal No. 2017AP1780-CR is remanded to the circuit court under WIS. STAT. 808.075(6) for the purpose of addressing the appellants postconviction motion. The appellants postconviction motion shall be filed by November 27, 2017. See WIS. STAT. RULE 809.82(2)(a). The circuit court shall decide the motion on or before December 27, 2017.</p> <p>FRO that a transcript of the postconviction motion hearing, if any and if necessary for the appeal, shall be ordered within three days of the date the order disposing of the postconviction motion is entered. The transcript shall be prepared, filed and served within ten days of the date it is requested, and the party requesting the transcript shall advise the court reporter of this deadline.</p> <p>FRO that the record in appeal No. 2017AP1780-CR shall be transmitted back to this court within five days of the disposition of the postconviction motion or the filing of the transcript of the postconviction motion hearing if ordered. The record shall include the proceedings on remand. See WIS. STAT. 808.075(7).</p> <p>FRO that appeal No. 2017AP1739-CR is placed on hold, pending return of the record in appeal No. 2017AP1780-CR.</p> <p>FRO that upon return of the record in appeal No. 2017AP1780-CR, appeals Nos. 2017AP1739-CR and 2017AP1780-CR will be consolidated. WIS. STAT. RULE 809.10(3).</p> <p>FRO that the appellants brief in appeal Nos. 2017AP1739-CR and 2017AP1780-CR will be due forty days after the return of the record in appeal No. 2017AP1780-CR.</p>
