IT IS ORDERED that the record is remanded to the circuit court for the purpose of addressing the appellants postdisposition motion. WIS. STAT. RULE 809.107(6)(am). The postdisposition motion shall be filed by March 12, 2015. The circuit court shall hold necessary proceedings and decide the motion on or before April 13, 2015.

IT IS FURTHER ORDERED that a transcript of the postdisposition motion hearing, if any and if necessary for the appeal, shall be ordered within three days of the hearing and shall be prepared within ten days of the date it is ordered. Counsel for the appellant shall provide the court reporter with a copy of this order.

IT IS FURTHER ORDERED that the record shall be transmitted back to this court within five days of the disposition of the postdisposition motion or, if ordered, the filing of the transcript of the postdisposition motion hearing. The record shall include the proceedings on remand.

IT IS FURTHER ORDERED that the time for filing the appellants brief is extended to fourteen days after the return of the record to this court and the appellants brief shall present all grounds for relief. WIS. STAT. RULE 809.107(6)(am).
