IT IS ORDERED that these appeals are remanded to the circuit court to permit G.H. and V.A. to pursue postjudgment motions but this court retains jurisdiction over the appeals. See *id.* The postjudgment motions shall be filed within twenty-one days of the date of this order. IT IS FURTHER ORDERED that the circuit court shall hold necessary proceedings and enter an order in each case containing the circuit courts findings and conclusions resolving the motions within sixty days of the date of this order. IT IS FURTHER ORDERED that a transcript shall be ordered within three days of the hearing, if appellate counsel deems a transcript of the postjudgment proceedings necessary for appeal, and any such transcript shall be served and filed within twenty days of the date it is ordered. A statement on transcript shall be filed within five days of the date of the hearing by each appellate counsel reflecting either that post-remand transcripts have been ordered or that such transcripts are not necessary for the appeals. Counsel for each appellant shall provide the court reporter with a copy of this order. IT IS FURTHER ORDERED that the clerk of circuit court shall retransmit the records to this court within ten days after the later of the entry of the circuit court orders resolving the postjudgment motions or the filing of the transcripts of the postjudgment motion hearing if such transcripts are ordered. The records shall include documents, including transcripts, filed pursuant to this remand, and the circuit courts orders resolving the postjudgment motions. See WIS. STAT. 808.075(7). IT IS FURTHER ORDERED that each appellant shall file a brief presenting all grounds for relief no later than fifteen days after the records are retransmitted to this court. See WIS. STAT. RULE 809.107(6)(am).
