Sanders shall, also within fourteen days of the date the circuit court enters its order, file a statement on transcript reflecting that transcripts of the proceedings after remand have been ordered or that all transcripts have been filed. IT IS FURTHER ORDERED that the transcripts of proceedings held pursuant to this remand shall be served and filed within twenty days after the transcripts are ordered.
