IT IS ORDERED that 21 days from the date of this order, the parties shall file simultaneous briefs addressing the following issues, which may have been addressed previously in State v. Longcore, 226 Wis. 2d 1, 594 N.W.2d 412 (Ct. App. 1999), on which we granted review and deadlocked, with an equally divided court, 2000 WI 23, 233 Wis. 2d 278, 607 N.W.2d 620:

(1) whether the officer had reasonable suspicion to stop Brown's vehicle because the officer believed that Wis. Stat. 347.13(1) was violated when not all the tail light bulbs on Brown's vehicle were working;
(2) whether, assuming an officer makes a good faith mistake of law on which the officer makes a traffic stop, does that mistake of law nevertheless require reviewing courts to conclude that the stop was not lawful.
