The postconviction motion shall be filed by October 14, 2013. The circuit court shall hold necessary proceedings and decide the motion on or before November 13, 2013.

IT IS FURTHER ORDERED that a transcript of the postconviction motion hearing, if any and if necessary for the appeal, shall be ordered within five days of the hearing and shall be prepared within twenty days of the date it is ordered. Counsel for the appellant shall provide the court reporter with a copy of this order.

IT IS FURTHER ORDERED that the record shall be transmitted back to this court within five days of the disposition of the postconviction motion or the filing of the transcript of the postconviction motion hearing if ordered. The clerk of the circuit court shall supplement the record to include the proceedings on remand.

IT IS FURTHER ORDERED that if any party is aggrieved by the decision of the circuit court regarding the postconviction motion, the party shall file in this court a written statement of objections within fourteen days after the record is returned to this court. A party that files a statement of objections need not file an additional notice of appeal or cross-appeal. WIS. STAT. 808.075(8).
