FRO that we retain jurisdiction of the appeal.		

FRO that the appellant shall file the postjudgment motion within eleven days of the date of this order. The circuit court shall decide the postjudgment issues by December 12, 2014.

FRO that if the appellant remains aggrieved following postjudgment proceedings, and intends to continue with this appeal, the appellant shall request any transcripts within five days after the circuit court's decision. If no transcripts are being requested, the appellant should immediately advise the clerk of the circuit court of that fact. The court reporter shall file and serve the transcripts within eleven days of the request. The clerk of the circuit court shall return the record to this court within five days after the last transcript is filed, or after the appellant advises the clerk that no transcripts will be ordered.

FRO that, if the appellant remains aggrieved following postjudgment proceedings and intends to continue with this appeal, the time to file the appellant's brief shall be eleven days after return of the record to this court. If the appellant does not intent to continue with the appeal, a notice of voluntary dismissal must be filed within that time.
