FRO that T.L.T.Shall file her postdispostion reconsideration motion in the circuit court w/in 15 days of the date of this order.

FRO that the circuit court shall conduct any necessary proceedings on the postdisposition reconsideration motion and enter an order containing its findings and conclusions resolving the motion w/in 60 days of the date of this order.

FRO that, if appellate counsel deems a transcript of any postdisposition proceedings necessary for appeal, the transcript shall be ordered w/in 3 days of the hearing. Any such transcript shall be served and filed w/in 20 days of the date it is ordered. Counsel for the appellant shall provide the court reporter with a copy of this order.

FRO that appellate counsel shall file a statement on transcript w/in 5 days of the date of the hearing, reflecting either that a postdisposition transcript has been ordered or that such a transcript is not necessary for this appeal.

FRO that the clerk of circuit court shall transmit the complete records in these matters, including any postdisposition materials, to this court w/in 10 days of the later of the entry of the circuit court order resolving the postdisposition motion or the filing of the transcript of the postdisposition hearing if such transcript is ordered.
