ORD that the motion is granted. This court shall retain jurisdiction over this appeal but will remand the record to the circuit court. The appellant shall file his post-termination motion in the circuit court within ten days of the date of this order. FRO that the circuit court shall hear and decide the motion within forty-five days of its filing. FRO that if appellate counsel deems a transcript of the post-termination proceedings necessary for appeal, counsel shall order a transcript within three days of the hearing. Any such transcript shall be served and filed by the court reporter within ten days of the date it is ordered. Counsel for the appellant shall file an original statement on transcript in this court and shall file a copy in the circuit court within five days of the date of the hearing. The statement on transcript shall reflect either that a post-termination transcript has been ordered or that such a transcript is not necessary for this appeal. Counsel for the appellant shall provide the court reporter with a copy of this order. FRO that the clerk of the circuit court shall return the record to the clerk of this court within ten days of the later of entry of the circuit courts decision on the motion OR the filing of the post-termination motion hearing transcript, if such transcript is ordered. The record shall include any additional documents filed on remand. FRO that the briefing schedule will run from the date the record is returned to this court. See WIS. STAT. RULE 809.107(6)(am).
