IT IS FURTHER ORDERED that T.R.D. shall, within five business days after this order, request preparation of any outstanding transcripts in this matter, file a supplemental statement on transcript in this court, and file a copy of the supplemental statement on transcript in the circuit court. IT IS FURTHER ORDERED that the clerk of circuit court shall, within three business days after the court reporter files and serves any transcript described in the supplemental statement on transcript, transmit such transcripts to the clerk of this court by supplemental return. IT IS FURTHER ORDERED that, within fifteen days after the supplemental return is filed in this court, T.R.D. shall file and serve an amended opening brief that incorporates any issues raised by the newly-available transcript or, by that same deadline, file and serve a statement that an amended brief is not required and that T.R.D. relies on the original brief submitted pursuant to this order.
