statement on transcript reflecting either that a postremand transcript has been ordered or that such a transcript is not necessary for this appeal. Counsel for the appellant shall provide the court reporter with a copy of this order.

IT IS FURTHER ORDERED that the clerk of circuit court shall retransmit the record to this court within ten days after the later of the entry of the circuit court order resolving the postjudgment motion or the filing of the transcript of the postjudgment motion hearing if such transcript is ordered. The record shall include documents, including transcripts, filed pursuant to this remand, and the circuit courts order resolving the postjudgment motion. See Wis. Stat. 808.075(7).

IT IS FURTHER ORDERED that the appellant shall file a brief presenting all grounds for relief no later than fifteen days after the record is retransmitted to this court. See Wis. Stat. Rule 809.107(6)(am).
