Counsel for the appellant shall provide the court reporter with a copy of this order. IT IS FURTHER ORDERED that the clerk of circuit court shall retransmit the record to this court within ten days of the later of the entry of the circuit court order resolving the postiudgment motion or the filing of the transcript of the postjudgment motion hearing if such transcript is ordered. The record shall include documents, including transcripts, filed pursuant to this remand, and the circuit court's order resolving the postjudgment motion. See Wis. Stat. 808.075(7).
