Counsel for the appellant shall provide the court reporter with a copy of this order. IT IS FURTHER ORDERED that the clerk of the circuit court shall return the records to the clerk of this court within ten days of the later of entry of the circuit courts decision on the motion OR the filing of the post-termination motion hearing transcript, if such transcript is ordered.
