IT IS ORDERED that these appeals are remanded to the circuit court to permit J.W. to pursue postdisposition motions but this court retains jurisdiction over these appeals. See id. The postdisposition motions shall be filed within twenty-one days of the date of this order.

IT IS FURTHER ORDERED that the circuit court shall hold necessary proceedings and enter orders containing the circuit courts findings and conclusions resolving the motions within sixty days after the date of this order.

IT IS FURTHER ORDERED that transcripts shall be ordered within three days of the hearings, if appellate counsel deems transcripts of the postdisposition proceedings necessary for appeal, and any such transcript shall be served and filed within twenty days of the date it is ordered.

IT IS FURTHER ORDERED that appellate counsel shall, within five days after the hearings, file statements on transcript reflecting either that postremand transcripts have been ordered or that such transcripts are not necessary for these appeals. Counsel for the appellant shall provide the court reporter with a copy of this order.

IT IS FURTHER ORDERED that the clerk of circuit court shall retransmit the records to this court within ten days after the later of the entry of the circuit court orders resolving the post-judgment motions or the filing of the transcripts of the postdisposition motion hearings if such transcripts are ordered. The records shall include documents, including transcripts, filed pursuant to this remand, and the circuit courts orders resolving the postdisposition motions. See WIS. STAT. 808.075(7).

IT IS FURTHER ORDERED that the appellant shall file a brief presenting all grounds for relief no later than fifteen days after the record is retransmitted to this court. See WIS. STAT. RULE 809.107(6)(am).
