IT IS ORDERED that the plaintiff-respondent, State of Wisconsin, is directed to file a response to the petition for review on or before September 13, 2019. The response should address, inter alia, the following issues: (1) Whether, before Mirandized, a reasonable person in Dobb's position would have felt free to terminate the encounter with police and leave the scene. See generally State v. Lonkoski, 2013 WI 30, 346 Wis. 2d 523, 828 N.W.2d 552 (defining "custody" for Miranda purposes). (2) Whether, before being Mirandized, police interrogated Dobbs. See generally State v. Harris, 2017 WI 31, 374 Wis. 2d 271, 892 N.W.2d 663 (defining "interrogation" for Miranda purposes). (3) Assuming for the sake of argument that Dobbs was subject to the custodial interrogation before being Mirandized, whether his later post-Miranda inculpatory statements were nevertheless admissible.
