ORD that the appeal is remanded to the circuit court to permit A.V. to pursue a postdisposition motion.

This court retains jurisdiction over the appeal during the remand period.

FRO that any postdisposition motion shall be filed within ten days of the date of this order.

FRO that the circuit court shall conduct any necessary proceedings and enter an order containing its findings and conclusions resolving the postdisposition motion within 60 days of this order.

FRO that a transcript shall be ordered within three days after the hearing, if appellate counsel deems a transcript of the postdisposition proceedings necessary for appeal, and any such transcript shall be served and filed within 20 days of the date it is ordered. Counsel for the appellant shall provide the court reporter with a copy of this order.

FRO that a statement on transcript shall be filed by appellate counsel within five days of the date of the hearing, reflecting either that a postdisposition transcript has been ordered or that such a transcript is not necessary for this appeal. The statement shall be filed with the clerk of this court, and a copy shall be filed with the clerk of the circuit court. See Wis. Stat. Rule 809.107(5)(d).

FRO that the clerk of the circuit court shall retransmit the records to this court within ten days of the later of the entry of the circuit court order resolving the postdisposition motion or the filing of the transcript of the postdisposition motion hearing if such transcript is ordered. The records shall include documents, including transcripts, filed pursuant to this remand, and the circuit court's order resolving the postdisposition motion. See Wis. Stat. 808.075(7).

FRO that the appellant shall file a brief presenting all grounds for relief no later than fifteen days after the records are retransmitted to this court. See Wis. Stat. Rule 809.107
