IT IS ORDERED that the record is remanded to the circuit court for the purpose of addressing the appellants postjudgment motion. Wis. Stat. Rule 809.107(6)(am). The postjudgment motion shall be filed within ten days of the date of this order. The circuit court shall hold necessary proceedings and decide the motion within thirty days of the date it is filed.  
IT IS FURTHER ORDERED that a transcript of the postjudgment motion hearing, if any and if necessary for the appeal, shall be ordered within three days of the hearing and shall be prepared within

ten days of the date it is ordered. Counsel for the appellant shall provide the court reporter with a copy of this order.

IT IS FURTHER ORDERED that the record shall be transmitted back to this court within five days of the disposition of the postjudgment motion or the filing of the transcript of the postjudgment motion hearing if ordered. The record shall include the proceedings on remand. See Wis. Stat. 808.075(7).

IT IS FURTHER ORDERED that the time for filing the appellants brief is extended to fourteen days after the return of the record to this court and the appellants brief shall present all grounds for relief. Wis. Stat. Rule 809.107(6)(am).
