Appellant may file a reply brief not exceeding seven pages of monospaced font, or 1,540 words of proportional font, within ten days of service of respondents brief. If counsel is not personally served, but served by first-class mail, the opposing party shall have three additional days to file and serve the brief. WIS. STAT. 801.15(5)(a). The parties shall file an original and five copies of their briefs with this court and serve opposing counsel with one copy. The parties do not contemplate any appellate motions or presenting more than three issues for this courts determination. Any deviation from these terms must be presented to this court by motion and may result in an order removing this case from the Expedited Appeals Program.
