The transcript shall be prepared, filed and served within ten days of the date it is requested, and the party requesting the transcript shall advise the court reporter of this deadline. FRO that the records shall be transmitted back to this court within five days of the disposition of the post-termination motion or the filing of the transcript of the post-termination motion hearing if ordered. The records shall include the proceedings on remand. See WIS. STAT. 808.075(7). FRO that the time for filing the appellant's brief is extended to fourteen days after the return of the records to this court and the appellants brief shall present all grounds for relief. WIS. STAT. RULE 809.107(6)(am).
