The post-judgment motion shall be filed within ten days of the date of this order. The circuit court shall hold necessary proceedings and decide the motion within thirty days of the date it is filed.

IT IS FURTHER ORDERED that a transcript of the post-judgment motion hearing, if any and if necessary for the appeal, shall be ordered within three days of the hearing and shall be prepared within ten days of the date it is ordered.
