Court Order

The briefs shall comply with the Expedited Appeals Brief Rules that are attached to this order. The appellant has agreed to submit no more than 2 issue(s) on appeal and may not increase the number of issues presented without prior notice of this court. Any deviation from the terms of this scheduling order may result in the appeal being removed from the expedited appeals program.
