IT IS ORDERED that this appeal is remanded to the circuit court to permit C.B. to pursue a postjudgment motion, but this court retains jurisdiction over the appeal. See WIS. STAT. RULE 809.107(6)(am). The postjudgment motion shall be filed within twenty-one days after the date of this order.

IT IS FURTHER ORDERED that the circuit court shall hold necessary proceedings and enter an order containing the circuit courts findings and conclusions resolving the motion within sixty days after the date of this order.

IT IS FURTHER ORDERED that a transcript shall be ordered within three days of the hearing, if appellate counsel deems a transcript of the postjudgment proceedings necessary for appeal, and any such transcript shall be served and filed within twenty days of the date it is ordered.

IT IS FURTHER ORDERED that appellate counsel shall, within five days after the hearing, file a statement on transcript reflecting either that a post-remand transcript has been ordered or that such a transcript is not necessary for this appeal. Counsel for the appellant shall provide the court reporter with a copy of this order.

IT IS FURTHER ORDERED that the clerk of circuit court shall retransmit the record to this court within ten days after the later of the entry of the circuit court order resolving the postjudgment motion or the filing of the transcript of the postjudgment motion hearing if any such transcript is ordered. The record shall include documents, including transcripts, filed pursuant to this remand, and the circuit courts order resolving the postjudgment motion. See WIS. STAT. 808.075(7).

IT IS FURTHER ORDERED that the appellant shall file a brief presenting all grounds for relief no later than fifteen days after the record is retransmitted to this court. See WIS. STAT. RULE 809.107(6)(am).
