IT IS ORDERED that this court's order dismissing these appeals is hereby vacated, the appeals are converted to merit appeals, and the appeal numbers shall be amended to remove the no-merit designation.  
IT IS FURTHER ORDERED that the records are remanded to the circuit court for the purpose of addressing the appellant's post-disposition motion. WIS. STAT. RULE 809.107(6)(am). The post-disposition motion shall be filed no later than November 25, 2022. The circuit court shall hold necessary proceedings and decide the motion within thirty days of the date it is filed.  
IT IS FURTHER ORDERED that a transcript of the post-disposition motion hearing, if any and if necessary for the appeal, shall be ordered within three days of the hearing and shall be prepared within ten days of the date it is ordered. Counsel for the appellant shall provide the court reporter with a copy of this order.  
IT IS FURTHER ORDERED that the records shall be transmitted back to this court within five days of

the resolution of the post-disposition motion or the filing of the transcript of the post-judgment motion hearing if ordered. The record shall include the proceedings on remand. See WIS. STAT. 808.075(7). IT IS FURTHER ORDERED that the time for filing the appellant's brief is extended to fourteen days after the return of the records to this court and the appellant's brief shall present all grounds for relief. WIS. STAT. RULE 809.107(6)(am).
