	IT IS FURTHER ORDERED that we retain jurisdiction of the appeal.	
	IT IS FURTHER ORDERED that the appellant shall file the postjudgment motion within eleven days of the date of this order. The circuit court shall decide the postjudgment issues by January 30, 2023.	
	IT IS FURTHER ORDERED that if the appellant remains aggrieved following postjudgment proceedings, and intends to continue with this appeal, the appellant shall request any transcripts within	

five days after the circuit courts decision. If no transcripts are being requested, the appellant should immediately advise the clerk of the circuit court of that fact. The court reporter shall file and serve the transcripts within eleven days of the request. The clerk of the circuit court shall return the record to this court within five days after the last transcript is filed, or after the appellant advises the clerk that no transcripts will be ordered.

IT IS FURTHER ORDERED that, if the appellant remains aggrieved following postjudgment proceedings and intends to continue with this appeal, the time to file the appellant's brief or no-merit report shall be eleven days after return of the record to this court. If the appellant does not intend to continue with the appeal, a notice of voluntary dismissal must be filed within that time.
