IT IS FURTHER ORDERED that the appellant shall file an amended brief that includes a discussion of what impact, if any, B.W. has on this appeal. The brief shall be filed within fifteen days of the date of this order.
IT IS FURTHER ORDERED that the respondent shall file a brief within ten days after the service of the later of the appellant's amended brief or the guardian ad litem's brief, if the guardian ad litem takes the position of the appellant. See WIS. STAT. RULE 809.107(6)(b). The respondent's brief shall also address the B.W. decision.
IT IS FURTHER ORDERED that the guardian ad litem, if taking the position of the appellant, shall file a brief within fifteen days of the date of this order. If taking the position of the respondent, the guardian ad litem's brief shall be filed within ten days after the service of the appellant's amended brief. See WIS. STAT. RULE 809.107(6)(d).
