Stoehr, 134 Wis. 2d 66, 70, 396 N.W.2d 177 (1986); Wis. Stat. 808.05(2) and (Rule) 809.61. Further, the court has jurisdiction over issues not certified because the court may review an issue directly on its own motion. Wis. Stat. 808.05(3); and IT IS FURTHER ORDERED that within 30 days after the date of this order the defendant-appellant must file either a brief in this court or a statement that no brief will be filed; that within 20 days of filing, the plaintiff-respondent must file either a brief or a statement that no brief will be filed; and that if a brief is filed by the plaintiff-respondent, within 10 days of filing, the defendant-appellant must file either a reply brief or a statement that no reply brief will be filed; and IT IS FURTHER ORDERED that in any brief filed in this court the parties shall not incorporate by reference any portion of their court of appeals' brief; instead, any material upon which there is reliance should be restated in the brief filed in this court; and IT IS FURTHER ORDERED that in the event any party elects not to file a brief in this court, the briefs previously submitted by that party to the court of appeals shall stand as that party's brief in the Supreme Court; and IT IS FURTHER ORDERED that this case be scheduled for oral argument on the same calendar assignment as Case No. 2023AP2319-CR, State v. Ga
