IT IS ORDERED that this appeal is remanded to the circuit court to permit S.L.L. to pursue a postdisposition motion, but this court retains jurisdiction over the appeal. See id. The postdisposition motion shall be filed within twenty-one days after the date of this order.

IT IS FURTHER ORDERED that the circuit court shall hold necessary proceedings and enter an order in this case containing the circuit court's findings and conclusions resolving the postdisposition motion within sixty days after the date of this order.

IT IS FURTHER ORDERED that a transcript shall be ordered within three days of the hearing, if appellate counsel deems a transcript of the postdisposition proceedings necessary for the appeal, and any such transcript shall be filed and served within twenty days of the date that the transcript is ordered. IT IS FURTHER ORDERED that appellate counsel shall, within five days after the hearing, file a statement on transcript in this case reflecting either that a post-remand transcript has been ordered or that such a transcript is not necessary for this appeal. See WIS. STAT. RULE 809.107(5)(d). Counsel for the appellant shall provide the court reporter with a copy of this order.

IT IS FURTHER ORDERED that the clerk of circuit court shall retransmit the record to this court within ten days after the later of the entry of the circuit court orders resolving the postdisposition motion or the filing of the transcript of the postdisposition motion hearing, if any such transcript is ordered. The record shall include documents, including transcripts, filed pursuant to this remand, and the circuit court's orders resolving the postdisposition motion. See WIS. STAT. 808.075(7).

IT IS FURTHER ORDERED that the appellant shall file a brief presenting all grounds for relief no later than fifteen days after the record is retransmitted to this court. See W
