IT IS ORDERED that the motion for a remand is granted. This court shall retain jurisdiction over the appeal, but will remand the record to the circuit court. The appellant shall file a postdisposition motion in

the circuit court within ten days of the date of this order.

IT IS FURTHER ORDERED that the circuit court shall conduct any necessary proceedings and enter an order containing its findings and conclusions resolving the post-disposition motion within forty-five days of its filing.

IT IS FURTHER ORDERED that appellate counsel shall order a transcript within three days of the hearing, if appellate counsel deems a transcript of the post-disposition proceedings necessary for appeal. Any such transcript shall be served and filed by the court reporter within ten days of the date it is ordered. Counsel for the appellant shall file an original statement on transcript in this court and shall file a copy in the circuit court within five days of the date of the hearing. The statement on transcript shall reflect either that a post-disposition transcript has been ordered or that such a transcript is not necessary for this appeal. Counsel for the appellant shall provide the court reporter with a copy of this order.

IT IS FURTHER ORDERED that the clerk of the circuit court shall return the record to the clerk of this court within ten days of the later of the entry of the circuit courts decision on the motion or the filing of the post-disposition motion hearing transcript, if such transcript is ordered. The record shall include the transcript and any additional documents filed on remand.

IT IS FURTHER ORDERED that the appellant shall file a brief presenting all grounds for relief no later than fifteen days after the supplemented record is retransmitted to this court, pursuant to WIS. STAT. RULE 809.107(6)(a).
