	IT IS ORDERED that the record is remanded to the circuit court to facilitate a fact-finding hearing pursuant to counsel's postdisposition motion with the circuit court. The circuit court shall resolve the motion by written order no later than August 5, 2024.	
	IT IS FURTHER ORDERED that a transcript of the motion hearing, if necessary for the appeal, shall be ordered within five days of the date the circuit court resolves the motion. The transcript shall be prepared, filed, and served within twenty days of the date it is requested, and the party requesting the transcript shall advise the court reporter of this deadline.	
	IT IS FURTHER ORDERED that the record shall be transmitted back to this court within five days of the resolution of the postdisposition motion or the filing of the transcript of the motion hearing if ordered, whichever is later. The record shall include the proceedings on remand. See WIS. STAT. 808.075(7).	
	IT IS FURTHER ORDERED that the time for filing the appellant's brief is extended to forty days after the return of the record to this court.
