FRO that in any brief file in this court the parties shall not incorporate by reference any portion of their court of appeals' brief or petition for review or response; instead, any material in these documents upon which there is reliance should be restated in the brief filed in this court; and  
FRO that the first brief filed in those court must contain, as part of the appendix, a copy of the decision of the court of appeals in this case; and  
that, if a party has not previously filed an electronic copy of the briefs filed on behalf of that party in the court of appeals, the party, within 30 days after the date of this order, must provide the clerk of this court with 10 copies of the brief previously filed on behalf of that party in the court of appeals but if the party

has already filed an electronic copy of such briefs, then there is no obligation to provide additional copies of those briefs to the clerk of this court; and  
FRO that the allowance of costs, if any, in connection with granting of the petition will abide the decision of this court on review.
