The statement on transcript shall reflect either that a post-termination transcript has been ordered or that such transcript is not necessary for this appeal. Counsel for the appellant shall provide the court reporter with a copy of this order. FRO that the clerk of the circuit court shall return the record to the clerk of this court within 10 days of the later of entry of the circuit court's decision on the motion or the filing of the postdisposition motion hearing transcript, if such transcript is ordered. The record shall include any additional documents filed on remand. FRO that the briefing schedule will run from the date the record is returned to this court.
