Counsel for the appellant shall provide the court reporter with a copy of this order.  
IT IS FURTHER ORDERED that a statement on transcript shall be filed by appellate counsel within five days of the date of the hearing, reflecting either that a postdisposition transcript has been ordered or that such a transcript is not necessary for this appeal. The statement shall be filed with the clerk of this court, and a copy shall be filed with the clerk of the circuit court. See WIS. STAT. RULE 809.107(5)(d).  
IT IS FURTHER ORDERED that the clerk of circuit court shall retransmit the record to this court within ten days of the later of the entry of the circuit court order deciding the postdisposition motion or the filing of the transcript of the postdisposition motion hearing if such transcript is ordered. The record shall include documents, including transcripts, filed pursuant to this remand, and the circuit courts order resolving the postdisposition motion. See WIS. STAT. 808.075(7).  
IT IS FURTHER ORDERED that the appellant shall file a brief presenting all grounds for relief no later than fifteen days after the record is retransmitted to this court. See WIS. STAT. RULE 809.107(6)(a).
