WIS. STAT. RULE 809.107(5)(d). Counsel for the appellant shall provide the court reporter with a copy of this order.  
IT IS FURTHER ORDERED that the clerk of the circuit court shall return the records to the clerk of this court within ten days of the filing of the postdisposition motion hearing transcript. The records shall include any additional documents filed on remand.
