IT IS ORDERED that the time under WIS. STAT. RULE 809.107(5)(b) for the circuit court clerk to transmit the record is extended; consistent with the deadlines set in this order, the circuit court clerk may delay transmitting the record to this court.

IT IS FURTHER ORDERED that E.S. shall file the postdisposition motion in the circuit court within fifteen days of the date of this order.

IT IS FURTHER ORDERED that the circuit court shall hold necessary proceedings and decide the motion on or before thirty days after the filing of the postdisposition motion.

IT IS FURTHER ORDERED that, if appellate counsel deems a transcript of any postdisposition proceedings necessary for the appeal, the transcript shall be ordered within three days of the circuit courts decision, and shall be served and filed within twenty days of the date it is ordered. Counsel for the appellant shall provide the court reporter with a copy of this order.

IT IS FURTHER ORDERED that if a postdisposition hearing or hearings is/are held, appellate counsel shall file a statement on transcript within five days after the last hearing, reflecting either that a postdisposition transcript has been ordered or that such a transcript is not necessary for the appeal.

IT IS FURTHER ORDERED that the clerk of circuit court shall transmit the complete record, including any postdisposition materials, to this court within ten days of the later of the disposition of the postdisposition motion or the filing of any postdisposition hearing transcript.

IT IS FURTHER ORDERED that E.S. shall file a brief presenting all grounds for relief within fifteen days after the record is filed in this court.
